**THE COMBINED MARTIAL SCIENCE PLEDGE TO STUDENTS:**

The COMBINED MARTIAL SCIENCE (hereinafter referred to as the School) will use its best efforts to assist the student in obtaining his or her maximum potential in the Martial Arts. The School is committed to providing and maintaining professional facilities, staff and a varied and regular class schedule. The student understands that the School is providing a service where two way communication is essential to the effective servicing of the student, agrees to communicate his/her needs and/or problems.

## MEMBERSHIP AGREEMENT

The School agrees to provide the student with lessons in the Martial Arts on a scheduled basis established by the School, each lesson to be approximately sixty minutes in duration.

Lessons scheduled may be modified at the discretion of the School from time to time for holidays, Martial Art tournaments and other School activities. The School shall give prior notice of such modifications by general announcement.

Without prior written request from the student, and without prior written approval of the School, no deviation of the established class schedule may be made by the student, and the failure of the student to attend any scheduled lesson shall terminate his or her rights to that lesson only.

The student recognizes that regular class attendance is important for the student's progress and understands that it is the student's responsibility to attend the classes. **It is further understood that the student is obligated to make payments whether or not the student attends classes.** The student further understands that failure to complete the lessons does not relieve the student of the obligation to pay the tuition in full.

The student understands further that strict observation of the rules and regulations relative to training include the use of protective equipment required by the school. This equipment will largely eliminate the possibility of accident or injury; however, the School does not warrant the protective equipment.

The student further agrees to waive any claim of damages against the school and/or its principals or its instructors in any case resulting

from the activity. The names of students and any photographs or motion pictures taken during the school's activities may be used for promotional purposes.

The parties agree that the costs for uniforms, test fees, tournament fees, protective equipment, and other School related activities are not covered by this document and remain the responsibility of the student.

The COMBINED MARTIAL SCIENCE student agrees that he/she will refrain from using the knowledge obtained from COMBINED MARTIAL SCIENCE and/or School in the Martial Arts with or without compensation. A student must not work in or own a martial art school for a distance of no less than 15 miles in all directions from COMBINED MARTIAL SCIENCE School.

The school reserves the right to display any trophy, medal, etc. won by any student for a period of one year.

Official belt recognition will be issued to the student by the School upon the successful completion of any examination and the requirements thereof.

The student has an option to cancel this agreement within 72 hours and obtain a refund of down payment less \$60.00 registration and processing fees, and uniform charge. This agreement may be canceled for reasons of death or permanent disability by providing a death certificate or disability statement by a certified physician. Should you move more than 25 miles and provide written proof you may also be released from the remainder of your liabilities.

This agreement is non-transferable without the express written consent of COMBINED MARTIAL SCIENCE.
